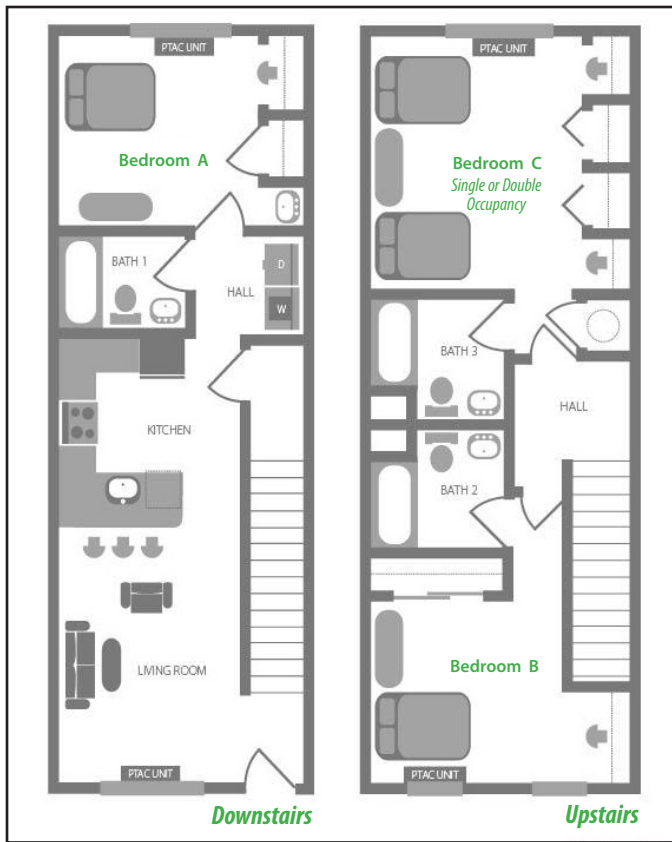

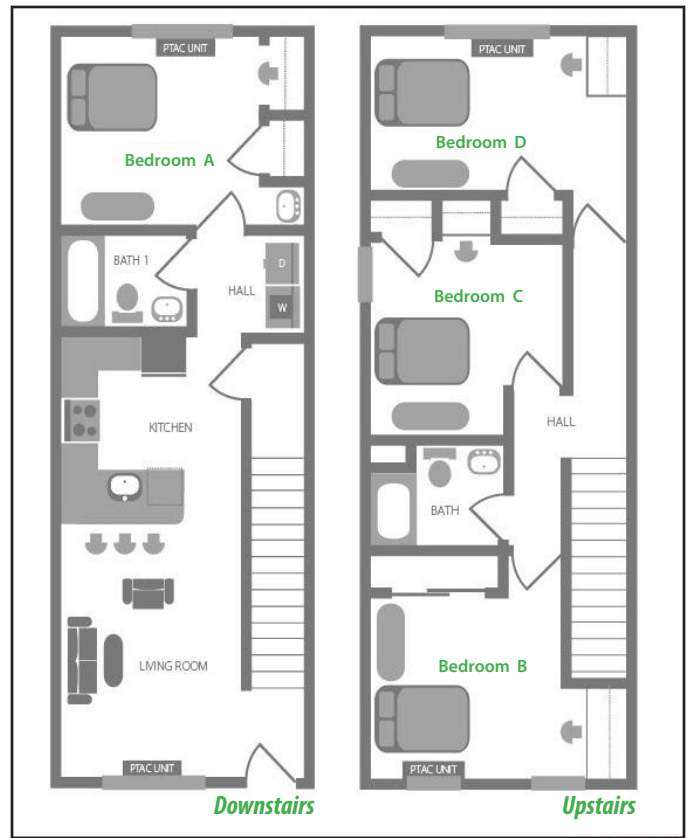

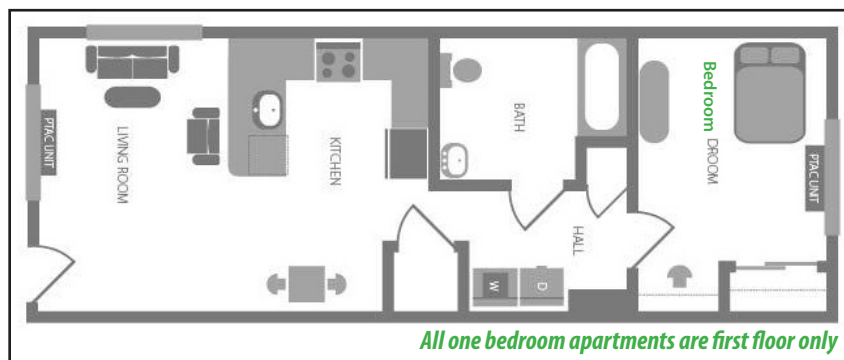
3 Bedroom Apartment
